

University of California **Regents** and **Officers** 2007-2008

Under the State Constitution, the university is governed by a Board of Regents.

The board consists of 26 members: 18 are appointed by the governor of California for 12-year terms; one is a student appointed by the Regents to a one-year term; and seven are ex officio members — the governor, the lieutenant governor, the speaker of the Assembly, the state superintendent of public instruction, the president and vice president of the Alumni Associations of the University of California, and the president of the university.

The governor is officially the president of the Board of Regents, but in practice the presiding officer is the chairman, who is elected by the Regents for a one-year term, as is the vice chairman.

The board operates through eight standing committees: audit, compensation, educational policy, finance, grounds and buildings, health services, investments, and oversight of the Department of Energy laboratories. With few exceptions, all matters requiring board action are first considered by the appropriate committee, which recommends action or reports to the board.

The board has delegated a broad range of authority and responsibility to the president of the university and has delegated authority to the faculty in matters relating to academic programs.

More than 400 individuals have served on the Board of Regents since the university was founded in 1868.

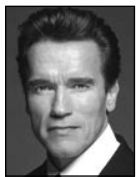

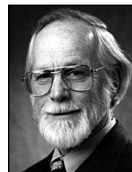

The Governor is the only ex officio member of the Committee on Governance.

The Regents' representatives to the California Postsecondary Education Commission and the superintendent of public instruction are ex officio members of the Committee on Educational Policy.

The Board of Regents meets six times a year in two-day meetings scheduled for Wednesday and Thursday. Standing committees meet as required, usually on the first day of business meetings. Special meetings of regents' committees or the full board may also be called as needed.
